Twenty-five percent (25%) of the shares subject to the option shall vest on June 11, 2017, and one thirty-sixth (1/36th) of the remaining shares subject to the option shall vest each month thereafter on the last day of the month, subject to the Reporting Person continuing to provide service through each such date.
3. Twenty-five percent (25%) of the shares subject to the option shall vest on July 21, 2018, and one thirty-sixth (1/36th) of the remaining shares subject to the Option shall vest each month thereafter on the last day of the month, subject to Reporting Person continuing to provide service through each such date.
4. One forty-eighth (1/48th) of the shares shall vest on a monthly basis, on the last day of the month, commencing on the January 1, 2018, subject to the Reporting Person continuing to provide service through each such date.
5. Twenty-five percent (25%) of the shares subject to the option shall vest on January 1, 2019, and one thirty-sixth (1/36th) of the remaining shares subject to the option shall vest each month thereafter on the last day of the month, subject to the Reporting Person continuing to provide service through each such date.
